Company **PARTNERS INVESTMENT NETWORK LIMITED**, which is offering their services thorough internet site <http://partnersinvestmentnetwork.com/>, has not obtained the Agency's authorization according to Market in Financial Instruments Act (official Gazette of the Republic of Slovenia 67/2007, 100/2007, 69/2008 and 40/2009) or any other securities law to carry out services in the financial instruments field in Slovenia and by the date of this warning the Agency has not received any documentation proving that the authorization is sought in order to acquire that authorization. Company **PARTNERS INVESTMENT NETWORK LIMITED** is not authorized under the MiFID directive to provide direct investment services and deals related to financial instruments on the territory of the Republic of Slovenia.
