NOTICE TO THE SHAREHOLDERS

1. DECISION OF EXTRAORDINARY GENERAL MEETING – AMENDMENT TO THE ARTICLES OF ASSOCIATION

In accordance with the decision of the Extraordinary General Meetings of Horizon on 16 March 2023, the Articles of Association of this open-ended investment company (*beveik*) will be amended on 3 April 2023 to allow the Board of Directors to decide to reserve share classes for investors who are shareholders of the share class in question on a given date. In addition, it was decided to expand the definition of the share class 'Comfort Portfolio Shares' in the Articles of Association so that the prospectus may specify that individuals who did not acquire these units as clients of one or more segments of one or more distributors, as stipulated in the prospectus, can retain these units, provided that they already held the units prior to the date specified by the prospectus.

2. AMENDMENTS TO THE PROSPECTUS AND KEY INFORMATION DOCUMENT

The Board of Directors has decided to amend the prospectus and key information document of the following sub-funds on 3 April 2023 as follows:

A) Name change of sub-funds
