

**Change of legal fund documentation for various funds on March 31, 2025**

As of March 31, 2025, of the prospectus of several funds will change (see scope per change).

1) Change of conditions Institutional Discretionary Shares

From March 31, 2025, the conditions for access to Institutional Discretionary Shares will change, specifically, this share class will be excluded for clients with a discretionary asset management agreement "Core Satellite".

Please find attached the prospectus of Horizon Access India Fund - Institutional Discretionary Shares, by way of example. This change has no impact on the PRIIPS-KID.

2) Change of name of Institutional Discretionary Shares within specific sub-funds

The name of the Institutional Discretionary Shares of some sub-funds will also be changed: in accordance with article 23 of the Articles of Association, the name of the Institutional Discretionary Shares will be changed to "Institutional Discretionary Shares EUR".

3) Change sub-risks for Horizon Access India Fund, Horizon Access Fund China and KBC Institutional Fund North America Responsible Investing

- For Horizon Access India Fund and Horizon Access Fund China: the 'exchange risk or currency risk' remains high, but because the different share classes are denominated in different currencies, a specific explanation is provided for each share class. In this context, there is also an impact on the PRIIPS-KID of the Institutional Discretionary Shares. - For KBC Institutional Fund North America Responsible Investing: the 'exchange risk or currency risk' for the Institutional Discretionary Shares will be changed to 'high' and therefore an explanation should also be added. In this context, there is also an impact on the PRIIPS-KID of the Institutional Discretionary Shares. Please find attached the prospectus and PRIIPS-KID (of the 'Institutional Discretionary Shares EUR') of KBC Institutional Fund North America Responsible Investing.
