BACKGROUND

Institutional Cash Series Plc (the “Entity”) is an open-ended investment company with variable capital. The Entity was incorporated in Ireland on 9 December 1998 with limited liability between its funds and is organised under the laws of Ireland and is regulated by the Central Bank of Ireland (“CBI”) as a public limited company pursuant to the Companies Act 2014 (as amended) and the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011 (as amended) (the “UCITS Regulations”).

The Entity is structured as an umbrella fund and comprises of separate funds (“Fund”) of the Entity. The shares of each Fund may be grouped into different classes of shares (each a “share class”). Each Fund will represent a separate portfolio of assets and may consist of one or more share classes. Each share class may apply different subscription and redemption provisions, charges, fees or brokerage arrangements. The creation of an additional class of shares will be notified to the CBI in advance. The portfolio of assets maintained for each Fund will be invested in accordance with the investment objectives and policies applicable to each Fund as set out in the prospectus and supplements.

While assets and liabilities that are specific to a share class within a Fund would be attributable to (and should be borne by) only that share class, there is no segregation of liabilities between share classes as a matter of Irish law. Due to the lack of segregation of liabilities as a matter of law, there is a risk that the creditors of a share class may bring a claim against the assets of the Fund notionally allocated to other share classes.

The term “Fund” or “Financial Product” shall be deemed to mean either a Fund or Funds of the Entity, or if the context so requires, the Manager or its delegate acting for the accounts of the relevant Fund. The term “BlackRock” and “Investment Manager” are used to represent BlackRock Investment Management (UK) Limited and/or BlackRock Capital Management, Inc. as appropriate. All references to “redeemable shares” shall be deemed to mean redeemable participating shares when Fund shares are classified as financial liabilities. The term “Directors” means the directors of the Entity.

Further details, including the investment objectives and minimum subscription requirements, are set out in the Entity’s prospectus and supplements.

Fund details

The Entity had 13 Funds in operation as at 31 March 2026.

Changes to the Entity during the financial period

With effect from 7 October 2025, Francis Drought resigned as a non-executive Director and Andrew Alabaster was appointed as a non-executive Director.

With effect from 8 October 2025, Niall Ryan was appointed as a non-executive Director.

On 9 October 2025, the Banking Circle (Dis) share class was launched for the BlackRock ICS US Dollar Liquidity Fund.

On 20 November 2025, the Banking Circle (Dis) share class was launched for the BlackRock ICS Sterling Liquidity Fund.

Effective 31 December 2025, the Secretary Apex Group Corporate Administration Services Ireland Limited, merged into Apex IFS Limited as part of an intra-group restructuring and was subsequently renamed Apex IFS Limited.

On 9 March 2026, an updated prospectus was issued for the Entity to facilitate the launch of GR (Acc T0) share class for the BlackRock ICS Sterling Liquidity Fund.

On 9 March 2026, a supplement was issued for the BlackRock Euro Ultra Short Core Bond Fund with changes to the initial offer period.

On 26 March 2026, the Banking Circle (Dis) share class was launched for the BlackRock ICS Euro Liquidity Fund.

Performance summary (continued)

Global economic overview

Global equities, as represented by the MSCI All Country World Index, returned (0.01)% (in USD terms) during the six months ended 31 March 2026. Equities made significant gains amid declining inflation (the rate of increase in the prices of goods and services), easing monetary policy from the world's largest central banks and strong corporate performance, especially in the technology sector. However, there were significant losses in March 2026 as conflict in the Middle East threatened prolonged disruption of global energy markets.

Economic growth in the US recovered from a subdued start to 2025, with figures for the third quarter of 2025 indicating stronger performance than had been forecast. However, growth for the fourth quarter of 2025 undershot expectations, in part as a result of the extended government shutdown that began in October 2025. In Japan, gross domestic product ("GDP") contracted in the third quarter of 2025 and rose by just 0.1% in the final quarter of 2025, while growth in the UK and Eurozone economies slowed in the second half of the year.

Most emerging markets continued to expand, although geopolitical issues and US trade policy created economic challenges. China's GDP increased by 5% over the course of 2025 as a rise in exports offset a slowdown in domestic economic activity. Meanwhile, India's GDP rose strongly over the first nine months of 2025 but slowed somewhat towards the year's end.

The US Federal Reserve (the "Fed") resumed its programme of interest rate cuts in the second half of 2025 as inflationary pressures eased and signs of weakness in the labour market emerged. The Bank of England ("BoE") continued to cut interest rates over the six months but officials at the European Central Bank ("ECB") left rates unchanged as inflation in the Eurozone remained near the official 2% target. However, policymakers warned that rates may need to be raised later in 2026 to address the expected spike in inflation caused by the conflict in Iran and consequent disruption in the supply of fuel and fertiliser.

The performance of global equity markets was initially positive. Following sharp declines in spring 2025 due to concerns that tariffs introduced by the US government could lead to higher inflation and lower growth, markets recovered on signs that the Trump administration was willing to enter trade negotiations. Positive corporate performance, particularly among firms involved in artificial intelligence ("AI") and cloud computing, continued to drive broad increases in share prices. However, there was volatility among software providers at the start of 2026 due to fears that AI could significantly disrupt business models in the sector.

For most of the period, equity markets in China continued to rise in the wake of new stimulus measures, and the Japanese market climbed as investors reacted positively to the appointment of a new prime minister. Performance among European stocks was largely positive as investors welcomed the news that European governments planned to significantly increase infrastructure and defence spending. However, there were broad losses on all global markets in March 2026. Conflict between the US and Iran led to sharp declines in equity prices after the Strait of Hormuz, a vital shipping lane for global energy markets, was effectively closed.

Globally, investments that factor in companies' environmental, social and governance ("ESG") characteristics faced regulatory concerns and shifting investor sentiment. ESG funds experienced significant outflows in the second half of 2025.

US government bond yields (which move inversely to bond prices) initially fell following the Fed's rate cuts but increased in March 2026 as investors priced in higher inflation and potential increases in interest rates.

Yields on UK and European government bonds also rose on concerns around the impact of an energy supply shock. Japanese government bond yields reached record highs at the start of 2026 in response to December 2025 interest rate increase by the Bank of Japan ("BoJ") and the possibility of higher government spending. Global corporate bond performance was broadly positive; continued resilience in the global economy alleviated credit concerns.

In commodities markets, Brent crude oil prices declined initially due to concerns about oversupply, but rose dramatically in 2026 due to conflict in the Middle East. Gold prices rose to record highs amid geopolitical tensions and signs that American trade and foreign policy could lead to prolonged turbulence in equity and bond markets. Having declined sharply in mid 2025 on US tariff fears, copper prices recovered after reports indicated the metal would be exempt from import levies.

In foreign exchange markets, the US dollar's performance relative to other major global currencies was largely positive. It rose against the euro, the Japanese yen and sterling but fell against the Chinese yuan.

Over the six-month period from September 2025 to March 2026, the Euro area macroeconomic and rates backdrop shifted from a late-cycle disinflation narrative to a more complex and increasingly hawkish environment, shaped by persistent domestic inflation, firmer growth, and ultimately a major geopolitical supply shock. At the start of the period, the ECB appeared comfortable holding policy rates at 2.00%, with President Lagarde signalling that disinflation was largely complete and that policy was in a good place, reinforced by unanimous decisions to leave rates unchanged. However, upside inflation risks were already building beneath that stable stance. Short-term inflation expectations moved above target, wage growth remained stronger than the ECB's forecasts, inflation swaps held above 2%, and headline consumer prices index inflation, after rising to 2.20% in September, only briefly returned to target by December. At the same time, several Governing Council members highlighted persistent food and services inflation, while Schnabel suggested growing tolerance for market pricing of future hikes and noted that structural forces, including artificial intelligence-driven investment and higher public spending, could be pushing the neutral rate higher and making current policy more accommodative.

This shift in inflation dynamics was reinforced by a firmer growth backdrop. Euro area activity proved more resilient than expected, with gross domestic product revised higher and business surveys reaching multi-year highs in November, supported by stronger fiscal expansion, Germany's infrastructure spending and record defence outlays. As a result, expectations for further easing steadily faded, particularly in the back end of the money market curve, where remaining rate-cut pricing became increasingly vulnerable to reversal. By early 2026, the outlook was then overtaken by a sharp geopolitical shock as conflict in the Middle East escalated, including Iranian strikes on key energy infrastructure and the effective closure of the Strait of Hormuz, a critical route for global energy supply. This materially worsened the inflation-growth trade-off and triggered a significant repricing across rates markets.

Although the ECB left rates unchanged throughout the period, including all three meetings in the first quarter of 2026, its message became notably more hawkish. The central bank revised its 2026 headline inflation forecast up to 2.60% from 1.9%, while cutting its gross domestic product growth forecast to 0.90%, bringing stagflation risk into clearer focus. The first visible pass-through from the energy shock emerged quickly, with Euro area headline consumer prices index inflation rising from 1.89% year-on-year in February to 2.52% in March. By the end of March, markets had moved a long way from the earlier assumption that the next ECB move would be a cut, with policymakers instead signalling that rate hikes could become necessary if inflation persistence broadened.

The six-month period marked a clear turning point. What began as a benign pause at the end of the easing cycle evolved into an environment of stickier inflation, stronger fiscal and structural support for growth, rising geopolitical risk and a materially higher probability that European yields would need to move higher as markets reassessed the medium-term path of ECB policy.

Over the six-month period to March 2026, the strategy remained cautiously positioned, with duration kept short of benchmark for most of the period as the view increasingly shifted towards the ECB holding rates steady and, over time, a greater risk of higher yields rather than further cuts. Positioning focused on harvesting carry in the three to six month part of the curve and selectively adding high-quality short-dated credit, including commercial paper, asset-backed commercial paper and floating rate notes, where spreads offered attractive income without materially increasing interest rate risk. As volatility and repricing intensified in the first quarter of 2026, the strategy became even more defensive, with reinvestment concentrated in very short maturities, although the move higher in yields by the end of March began to create more attractive opportunities to add duration selectively. Overall, portfolio duration declined from around 0.23 years in October to 0.17 years by the end of March, while spread duration tightened from 0.84 years to 0.66 years, reflecting a disciplined approach to liquidity, carry generation and risk control.

Over the six-month period to March 2026, with overnight reverse repurchase agreement levels consistently at or above the Euro Short-Term Rate, we maintained a preference for holding additional liquidity in the government Fund while selectively adding treasury bills where value was attractive. We used periods of curve dislocation to extend modestly into the three to six month sector and selectively into fourth quarter year-end maturities, although we remained cautious towards the end of March given increased volatility around the ECB meeting. Overall, the strategy remained defensive but opportunistic, with portfolio positioning gradually lengthening over the period and weighted average maturity increasing from 19 days at the end of 2025 to 27 days by the end of the first quarter of 2026.

Over the six-month period from September 2025 to March 2026, the United Kingdom macro backdrop shifted from a late-2025 cooling phase, marked by softer labour market conditions and easing inflation, to a far more challenging environment shaped by an external energy shock and a sharp repricing of the monetary policy outlook. In the final months of 2025, the domestic economy showed clearer signs of moderation. Unemployment rose to 5.1% in the three months to October, its highest level since early 2021, payroll data pointed to weaker employment through November, and wage growth excluding bonuses slowed to 4.6%, with private-sector pay falling below 4% for the first time since 2020. Inflation also eased materially, with headline consumer prices index inflation falling to 3.2% in November, the lowest level in eight months, as food inflation declined sharply, although services inflation remained relatively sticky.

Against this backdrop, the BoE responded with a 25 basis point rate cut, taking bank rate to 3.75%, its lowest level in nearly three years, as inflation and growth both softened. The narrow vote highlighted continued division within the monetary policy committee, but the decision still marked a shift towards a more supportive stance. At that stage, expectations were building for a gradual move towards further easing in 2026, although persistent wage pressures and uncertainty around the neutral rate meant the path remained finely balanced.

That narrative changed abruptly in the first quarter of 2026 following a major geopolitical shock in the Middle East, including Iranian missile strikes on key energy infrastructure and the effective closure of the Strait of Hormuz. This triggered a sharp reassessment of inflation risks and a significant repricing across the United Kingdom money market curve. In just three weeks, market pricing moved from implying more than 50 basis points of rate cuts at the end of February to discounting around 100 basis points of tightening over one year by mid-March. Although the BoE kept rates unchanged at 3.75%, its tone turned notably more hawkish, warning that it stood ready to respond if the shock led to more persistent inflation. It also revised near-term inflation forecasts higher, expecting consumer prices index inflation to reach 3.5% in March, around 50 basis points above pre-conflict expectations.

The six-month period marked a clear reversal in the United Kingdom rates narrative. What began as a domestic story of cooling activity, moderating wage growth and easing inflation evolved into a much more uncertain environment in which geopolitical developments reintroduced meaningful upside inflation risk and forced markets to abandon expectations of near-term cuts. By the end of March 2026, the BoE was no longer seen as moving steadily towards easier policy, but instead as facing a more difficult trade-off between weak domestic growth and the risk of renewed inflation pressure.

Over the six-month period, the strategy remained conservatively positioned, with a large allocation to reverse repurchase agreements and most reinvestment kept in overnight to three-month maturities, while selectively adding 3-month and 6-month treasury bills when levels improved. This preserved a strong liquidity profile and allowed duration to be added only gradually, leaving weighted average maturity broadly stable by the end of March 2026 at 27 days.

Over the six-month period from September 2025 to March 2026, the United States macroeconomic and policy backdrop remained challenging, with the Fed balancing persistent inflation pressures against mixed labour market signals, while money markets and short-dated yields remained highly sensitive to shifts in policy expectations. In late 2025, incoming data continued to test the Fed's dual mandate, as inflation remained sticky and labour market indicators sent a mixed message, exposing a growing divergence of views among policymakers. The outlook was further complicated by a prolonged government shutdown, which delayed key data releases and added uncertainty for both the Fed and markets. Although the Fed continued to ease policy through the end of 2025, lowering the federal funds target range to 3.50% to 3.75% in December, the market response was less straightforward. Short-dated yields moved lower overall, but uncertainty around the longer-run neutral rate kept the path uneven.

Funding conditions also became an important feature of the backdrop. Pressure in short-term funding markets intensified and led the Fed to end its quantitative tightening programme and resume treasury purchases in December, in order to keep overnight funding rates anchored within the target range. This highlighted that, even as rates were being lowered, market functioning and liquidity conditions remained a key policy concern.

As 2026 began, markets expected the Fed to adopt a more patient and data-dependent stance following the rate cuts delivered at the end of the prior year. That view was initially supported by signs of a softer labour market, with hiring slowing materially during the first quarter, even if changes in labour supply suggested underlying conditions were somewhat more stable than headline figures implied. However, the scope for further easing was constrained by inflation, which remained elevated. Core personal consumption expenditures inflation, the Fed's preferred inflation measure, rose to 3.1% year-on-year, showing that price pressures had not yet returned to a level consistent with policy comfort.

The outlook became more difficult still as tensions in the Middle East escalated, pushing energy prices higher and creating wider supply disruptions that risked lifting inflation globally, including in the United States. This shock reinforced concerns that inflation could remain higher for longer and led investors to scale back expectations for further monetary easing in both 2026 and 2027. As those expectations were reduced, United States yields moved sharply higher and the money market curve steepened, with one-year yields rising more than the rest of the front end.

The period marked a clear shift in the United States rates narrative: what began as a cautious easing cycle against a backdrop of mixed domestic data evolved into a more uncertain environment in which sticky inflation, funding pressures and an external energy shock limited the scope for further policy accommodation and pushed yields higher as markets reassessed the medium-term path of Fed policy.

1. General information

The Entity is an open-ended investment company domiciled and incorporated under the laws of Ireland as a public limited company. The Entity is authorised by the CBI and is governed by the provisions of the UCITS Regulations with its registered office at 200 Capital Dock, 79 Sir John Rogerson's Quay, Dublin 2, D02 RK57, Ireland.

2. Significant accounting policies

2.1 Basis of preparation

The financial statements of the Entity are prepared in accordance with Financial Reporting Standard 104 Interim Financial Reporting ("FRS 104") applicable in the United Kingdom and Republic of Ireland. The principal accounting policies and estimation techniques are consistent with those applied to the previous annual financial statements.

All amounts have been rounded to the nearest thousand, unless otherwise indicated. Amounts which are less than 500 in each Fund's base currency, have been rounded down to zero.

3. Financial risks

Each Fund's investment activities expose it to the various types of risk which are associated with the financial instruments and markets in which it invests. The risks are substantially consistent with those disclosed in the previous annual financial statements.

3.1 Market risk arising from price risk

Price risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk or currency risk), whether those changes are caused by factors specific to the individual financial instrument or its issuer, or factors affecting similar financial instruments traded in the market. Local, regional or global events such as war, acts of terrorism, the spread of infectious illness or other public health issue, recessions, climate change or other events could have a significant impact on each Fund and market prices of its investments.

A key metric used by the BlackRock Risk and Quantitative Analysis Group to measure market risk is Value-at-Risk ("VaR") which encompasses currency, interest rate and price risk. VaR is a statistical risk measure that estimates the potential portfolio loss from adverse market movements in an ordinary market environment. VaR analysis reflects the interdependencies between risk variables, unlike a traditional sensitivity analysis.

The one-day VaR based on 99% confidence level is outlined in the table below:

4. Fair value hierarchy

Each Fund classifies financial instruments measured at fair value using a fair value hierarchy. The fair value hierarchy has the following categories:

Level 1: The unadjusted quoted price in an active market for identical assets or liabilities that the entity can access at the measurement date.

Level 2: Inputs other than quoted prices included within level 1 that are observable (i.e. developed using market data) for the asset or liability, either directly or indirectly. This category includes instruments valued using: quoted market prices in active markets for similar instruments; quoted prices for identical or similar instruments in markets that are considered less than active; or other valuation techniques where all significant inputs are directly or indirectly observable from market data.

Level 3: Inputs are unobservable (i.e. for which market data is unavailable) for the asset or liability. This category includes all instruments where the valuation techniques used include inputs not based on market data and these inputs could have a significant impact on the instrument's valuation. This category also includes instruments that are valued based on quoted prices for similar instruments where significant entity determined adjustments or assumptions are required to reflect differences between the instruments and instruments for which there is no active market.

4. Fair value hierarchy (continued)

Specific valuation techniques used to value financial instruments classified as level 2 include:

- (i) for debt instruments, the use of quoted market prices or dealer quotes for similar instruments;
- (ii) for foreign currency forwards, present value of future cash flows based on the forward exchange rates at the condensed balance sheet date; and
- (iii) for other financial instruments, discounted cash flow analysis.

The level in the fair value hierarchy within which the fair value measurement is categorised in its entirety is determined on the basis of the lowest level input that is significant to the fair value measurement in its entirety. For this purpose, the significance of an input is assessed against the fair value measurement in its entirety. If a fair value measurement uses observable inputs that require significant adjustment based on unobservable inputs, that measurement is a level 3 measurement. Assessing the significance of a particular input to the fair value measurement in its entirety requires judgement, considering factors specific to the asset or liability.

The determination of what constitutes 'observable' inputs requires significant judgement. The Directors consider observable inputs to be market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by independent sources that are actively involved in the relevant market.

6. Taxation

Irish tax

Under current law and practice, the Entity qualifies as an investment undertaking as defined in Section 739B of the Taxes Consolidation Act, 1997, as amended. On that basis it is not chargeable to Irish tax on its income or gains. However, Irish tax may arise on the occurrence of a 'chargeable event'. A chargeable event includes any distribution payments to shareholders or any encashment, redemption, cancellation or transfer of shares and the holding of shares at the end of each eight year period beginning with the acquisition of such shares.

No Irish tax will arise on the Entity in respect of chargeable events in respect of:

- a) A shareholder who is neither Irish resident nor ordinarily resident in Ireland for tax purposes, at the time of the chargeable event, provided appropriate valid declarations in accordance with the provisions of the Taxes Consolidation Act, 1997, as amended, are held by the Entity; or the Entity has been authorised by the Irish Revenue to make gross payments in the absence of appropriate declarations; and
- b) Certain exempted Irish tax resident shareholders who have provided the Entity with the necessary signed annual declarations.

Overseas tax

Dividends, interest and capital gains (if any) received on investments made by the Entity may be subject to withholding taxes imposed by the country from which the investment income/gains are received, and such taxes may not be recoverable by the Entity or its shareholders.

For financial reporting purposes, and in accordance with FRS 104, the Entity must recognise a provision for deferred tax payable arising from material timing differences between the taxation of unrealised gains in the financial statements and actual realisable taxable profits.

The Organisation for Economic Co-operation and Development ("OECD") released Pillar Two Model Rules, which contemplate a global 15% minimum tax rate. The OECD continues to release additional guidance, including administrative guidance on interpretation and application of Pillar Two, and many countries are passing and updating legislations as well as local guidance to comply with Pillar Two.

Based on the available legislation and information, the Entity does not expect Pillar Two to have material impact to its provision for income taxes for the six months ended 31 March 2026. However, the rules are subject to negotiation and change. The Entity will continue to evaluate the potential future impacts of Pillar Two and will continue to review and monitor the issuance of additional guidance.

7. Share capital

Authorised

The authorised share capital of the Entity is 40,000 subscriber shares of a par value of €1.00 each and 500,000,000,000 participating shares of no par value.

Subscriber shares

3 subscriber shares are currently in issue and are held by the Manager and nominees of the Manager at 31 March 2026 and 30 September 2025. They do not form part of the NAV of the Entity. They are thus disclosed in the financial statements by way of this note only. In the opinion of the Directors this disclosure reflects the nature of the Entity's investment business.

Voting rights

The holders of the subscriber shares and redeemable shares shall, on a poll, be entitled to one vote per share.

Efficient portfolio management techniques

The Directors may, on behalf of each Fund and subject to the conditions and within the limits laid down by the CBI and the prospectus, employ techniques and instruments relating to transferable securities for hedging purposes (to protect an asset of a Fund against, or minimise liability from, fluctuations in market value or foreign currency exposures) or for efficient portfolio management purposes (with a view to achieving a reduction in risk, a reduction in cost or an increase in capital or income returns to the Fund provided such transactions are not speculative in nature). Investment in FDI which give exposure to foreign exchange will only be used for hedging purposes. Such techniques and instruments may include investments in exchange-traded or OTC FDIs, such as futures and currency forwards (which may be used to manage market and currency risk respectively), options (including call and put options which may be used to achieve cost efficiencies), swaps, including credit default swaps (which may be used to manage interest rate and credit risk respectively), and contracts for difference. A Fund may also invest in the FDI as part of its investment strategy where such intention is disclosed in the Fund's investment policy and provided that the counterparties to such transactions are institutions subject to prudential supervision and, in relation to OTC transactions, belong to categories approved by the CBI.

The Investment Manager employs a risk management process in respect of the Funds in accordance with the requirements of the Central Bank to enable it to accurately monitor, measure and manage, the global exposure from FDIs ("global exposure") which each Fund gains. The Investment Manager uses a methodology known as the Commitment Approach in order to measure the global exposure of the Funds and manage the potential loss to them due to market risk. The Company will, on request, provide supplemental information to shareholders relating to the risk management methods employed, including the quantitative limits that are applied and any recent developments in the risk and yield characteristics of the main categories of investment.

In addition to the investments in FDIs noted above, the Funds may employ other techniques and instruments relating to transferable securities and money market instruments subject to the UCITS regulations and to conditions imposed by the CBI such as repurchase/reverse repurchase transactions and securities lending.

The underlying exposure obtained through FDIs and the identity of the counterparties to these FDIs at the financial period end are disclosed on the relevant Fund's schedule of investments.

Reverse repurchase transactions

All reverse repurchase transactions are entered into by each Fund with a counterparty under a Global Master Repurchase Agreement ("GMRA"). All collateral received by each Fund under the GMRA is transferred under a title transfer arrangement. Collateral received by each Fund is held in an account in the name of the Depositary on behalf of each Fund, and in case of tri-party reverse repurchase transactions with a tri-party collateral manager in the name of the Depositary on behalf of each Fund. Collateral received is segregated from the assets belonging to the Fund's Depositary.
